



CHARTER TOWNSHIP OF WEST BLOOMFIELD FIRE ALARM FEE SCHEDULE

CONTRACTOR REGISTRATIONS/LICENSES

a) Fire Alarm Contractor..... \$25

APPLICATION FEE on all permits (non-refundable & not credited to permit fee)..... \$100

PLAN REVIEW FEES/OVERTIME PLAN REVIEW

- a) 30% of fire sprinkler/suppression permits (\$150 minimum).
- b) Where review of construction documents is performed by township employees, the review fee shall be charged at \$75 per hour (i.e., revised drawings, deferred documents, etc.).
- c) Where review of construction documents is performed by outside consultants, the review fee shall be charged at 1.5 times the actual cost. Payment shall be in advance of the review based on estimated cost.

FIRE SPRINKLER SYSTEMS

- a) Building area less than 5,000 sq. ft. \$250
- b) Building area less than 10,000 sq. ft. \$350
- c) Building area less than 20,000 sq. ft. \$650
- d) Building area more than 20,000 sq. ft., plus per 1,000 sq. ft. over the first 20,000 sq. ft..... \$5
- e) Flushing, each \$75
- f) Installation of central supervision of existing suppression system \$200
- g) Fire Control Master Panel, Annunciator Panel, and Power Panel, each..... \$50
- h) Master Panel – Each Circuit or Zone..... \$50
- i) Modification of less than 6 detectors of an existing system \$150
- j) Multi-story – each floor above first..... ½ the original fee

RE-INSPECTION FEE (re-inspection fees to be paid prior to re-call) \$75

SAFETY AND SPECIAL INSPECTION FEE

For the purpose of determining conformance with codes (Observable components for Life/Safety issues only)

- a) Annual fire inspection (surcharge for third and each additional inspection)..... \$75
- b) Special and safety inspection..... \$75
- c) Compliance inspections (per hour)..... \$75
- d) Inspections for which no fee is specifically indicated (per hour)..... \$75

Work Started Prior To Permits

For work started prior to issuance of the Building Permit, the fee shall be charged at a rate of 2 times the usual permit fee. These additional fees are for Code Enforcement Investigation, administrative procedures and follow up costs. In cases where special inspections are required, an additional special inspection fee shall be charged for each visit to the site prior to any building permit review.

Cancellations and Refunds

None granted 6 months from date of issuance. Upon written request, prior to commencement of any work, permits may be cancelled by the holder. Refund all fees except; application fee, 25% of permit fee plus \$75 per inspection plus plan review fees. In those cases where work has commenced, there will be no refunds.
